# Effective date: April 1, 2025 BainUltra<sup>®</sup> consumer terms and conditions

## 1. Agreement & Scope

These Terms & Conditions apply to consumers who have purchased a BainUltra<sup>®</sup> product through an authorized dealer. BainUltra designs and manufactures high-quality bathtubs and wellness products, which are sold exclusively through its dealer network. BainUltra does not sell directly to consumers and is not responsible for the sales policies, payment terms, or refund conditions of its dealers. Each dealer is solely responsible for its own sales conditions, including returns and refunds. BainUltra will not intervene in disputes between a consumer and a dealer unless legally required to do so. Consumers should direct all purchase-related inquiries, including cancellations and returns, to their dealer. These Terms & Conditions govern only the relationship between BainUltra and consumers regarding warranty, product use, and customer support.

## 2. Damage During Transportation

Consumers are responsible for inspecting their BainUltra product upon delivery. If any damage is found, the following procedures apply:

#### 2.1 Visible Damage at Delivery

Any damage to the packaging must be noted on the delivery receipt before signing. Consumers must immediately report the issue to their dealer, including photographs of the damaged packaging. Failure to note visible damage at the time of delivery may result in the denial of a claim. Notwithstanding the foregoing, BainUltra shall not be held liable for damage to the packaging caused by improper handling, negligence, or fault of the Consumer or any third party after delivery has been completed. Any damage caused during transportation remains the responsibility of the carrier and should be reported in accordance with the dealer's policies.

#### 2.2 Concealed Damage

If damage is discovered after unpacking, consumers must notify their dealer within 48 hours of delivery, providing photographs of the damaged product and packaging.

#### 2.3 Failure to Report

If damage is not reported within the specified timeframe, claims may be denied, and BainUltra assumes no responsibility. Consumers must retain all packaging materials, labels, manuals, and documentation until the product has been fully inspected and confirmed as undamaged. Failure to retain these materials may impact the ability to process a claim and could result in delays or denials.

## 3. Warranty Policy

BainUltra stands behind the quality of its products and provides the following limited warranty:

### 3.1 Duration

20-Year Limited Warranty on acrylic, FineStone<sup>®</sup>, and motor units. 5-Year Warranty on electronic components such as controllers and Illuzio. Consumers should consult the warranty document for coverage on other specific parts.

### 3.2 Coverage

Warranty covers manufacturing defects but does not cover damage caused by improper installation, misuse, lack of maintenance, excessive or improper use, exposure to harsh chemicals, or alterations to the product. To initiate a warranty claim, consumers must contact BainUltra and provide proof of purchase. Full warranty details are available on BainUltra's website or upon request.

### 3.3 Warranty Claim Process

To initiate a warranty claim, consumers must contact BainUltra directly and provide proof of purchase. BainUltra handles the entire claim process and will coordinate any necessary actions. BainUltra may, at its sole discretion, require that repairs be performed by an authorized service provider.

Full warranty details are available on BainUltra's website or upon request. Consumers must register their product within three (3) months of installation to activate warranty coverage. However, failure to register does not affect consumers' rights under the legal warranty provisions of the *Consumer Protection Act* (CQLR, c. P-40.1) and the *Civil Code of Québec* (CQLR, c. CCQ-1991).

## 4. Installation Guidelines

BainUltra is not responsible for indirect, incidental, or consequential damages, including installation costs, labor fees, or water damage resulting from improper installation, misuse, failure to follow installation guidelines, or site-specific constraints.

Consumers are responsible for ensuring, prior to installation, that the product is compatible with the specific conditions of the installation site.
